For example, FOREX trading offers completely different possibilities: In the EU, a maximum leverage multiplier of 1:30 is allowed. In the UAE, in contrast, one has the chance to access a leverage multiplier of 1:500. This changes the possibilities enormously, because here it depends massively on the question of the amount of the swing of the trend for the winning possibility. As you can see in the chart on the right: The EU-Trader has to wait until the price swings all the way up to get a 5% return on the Trade. The UAE-Trader achieves this at a much lower level. He achieves this 16 times sooner! As a result, in the EU, you either have to be right 16 times longer or place 16 times more successful Trades to get the corresponding return. The EU-Trader cannot win against the UAE-Trader! No Chance!

From the feedback of the Key Note, the "DUBAI TRADING CHALLENGE" (DTC) was invented and developed. 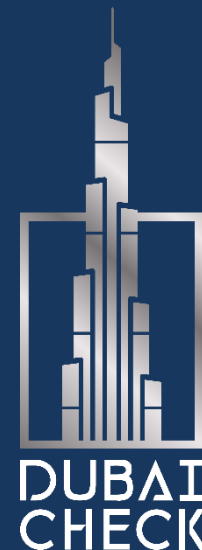
